Executive Summary

Background

On July 14, 2020 the Board approved CDBG-CV1 funding to be used by small cities, metro cities and the county for various activities to prevent, prepare for, and respond to the coronavirus (COVID-19). Not all of these funds were expended. On March 9, 2021 the Board approved CDBG-CV funding to be used for rental assistance, rehabilitation and shelter to prevent, prepare for, and respond to COVID-19. various activities to prevent, prepare for, and respond to the coronavirus (COVID-19). Not all of these funds were expended. On March 24, 2023, the Board approved the reallocation of CDBG-CV funds in order to spend the funding by SEPTEMBER 30, 2023.
