These notices shall satisfy two separate but related procedural requirements for activities to be undertaken by the County of Orange.

REQUEST FOR RELEASE OF FUNDS

On or about December 5, 2023,the County of Orange, Housing & Community Development will submit a request to the U.S. Department of Housing and Urban Development (HUD) Office of Public and Indian Housing for the release of 13 Orange County Housing Authority (OCHA) Veterans Affairs Supportive Housing (VASH), Mainstream and/or Housing Choice Project-Based Vouchers (PBVs) as authorized under Housing Opportunity Through Modernization Act of 2016 (HOTMA) to undertake a development known as **Lincoln Avenue Apartments** (Development), estimated total funding (including non-HUD funding sources) is \$40,663,367.

The Development is in the City of Buena Park at 7101 Lincoln Avenue, a property that will be acquired by C&C Development Co., LLC (Developer) from the City of Buena Park. The Development would involve the demolition of the existing commercial building and construction of a new affordable multi-family residential rental project It will consist of 54 affordable/supportive housing units, plus 1 on-site manager's unit.

The Developer has requested 13 OCHA PBVs (VASH, Mainstream and/or Housing Choice PBVs) under the County of Orange 2023 Supportive Housing Notice of Funding Availability. These 13 PBVs will be guaranteed for 20 years and target individuals earning no more than 30% of the Area Median Income (AMI).

FINDING OF NO SIGNIFICANT IMPACT

The County of Orange Housing & Community Development has determined that the development will have no significant impact on the human environment. Therefore, an Environmental Impact Statement under the National Environmental Policy Act of 1969 (NEPA) is not required. Additional project information is contained in the Environmental Review Record (ERR). The ERR will be made available to the public for review either electronically or by U.S mail. PUBLIC COMMENTS

Notice is hereby further given to provide the public an 18-day review period beginning November 16 to December 4, 2023. Any individual, group, or agency may submit written comments on the

All comments received by December 4, 2023, will be considered by the County of Orange prior to authorizing submission of a request for release of funds. Comments should specify which Notice they are addressing.

ENVIRONMENTAL CERTIFICATION

The County of Orange certifies to HUD that Julia Bidwell in her capacity as Director of OC Housing and Community Development, consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. HUD's approval of the certification satisfies its responsibilities under NEPA and related laws and authorities and allows the County of Orange to use Program funds.

OBJECTIONS TO RELEASE OF FUNDS

HUD will accept objections to its release of funds and the County of Orange certification for a period of fifteen days following the anticipated submission date or its actual receipt of the request (whichever is later) only if they are on one of the following bases: (a) the certification was not executed by the Certifying Officer of the County of Orange; (b) the County of Orange has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR part 58; (c) the grant recipient or other participants in the development process have committed funds, incurred costs or undertaken activities not authorized by 24 CFR Part 58 before approval of a release of funds by HUD; or (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted via email in accordance with the required procedures (24 CFR Part 58, Sec. 58.76) and shall be addressed to HUD Los Angeles Office of Public Housing at <a href="https://example.com/hub.co
