The FY 2026-27 (AAP) is an all-encompassing document that provides a basis and strategy for the annual use for all federal funds granted to the Urban County of Orange by the U.S. Department of Housing and Urban Development (HUD) under the Community Development Block Grant (CDBG), Home Investment Partnership (HOME), remaining HOME-ARP funding and Emergency Solutions Grant (ESG) programs. The FY 2026-27 AAP also addresses related local funding received by OC Housing & Community Development. The FY 2026-27 AAP indicates preliminary awards based on HUD allocations for FY 2025-26. These appropriations support public facilities and improvements, public services, housing rehabilitation, and affordable housing development activities that benefit low-and moderate-income households.

INVITATION TO BE HEARD: Notice is hereby further given to provide the public with a 30-day review period for the FY 2026-27 Annual Action Plan, to submit any concerns and/or comments. All persons either favoring or opposing the Annual Action Plan are invited to present their views in writing or before the OC Board of Supervisors.
